#### **IMPORTANT NOTES:**

#### (\*) W4.5-4.0-3.5 Teams Advancing to Semifinals (SF)/FINAL (F):

CHAMPIONSHIPS PROCEDURE TO DETERMINE THE FOURTH TEAM FOR SEMIFINAL PLAY IN A THREE (3) FLIGHT ROUND ROBIN:

- I. If one or more round robin flights result in a first-place tie, the round robin winner shall be determined by the first of the following procedures that does so:
  - a. Individual Matches. Winner of the most individual matches in the entire competition.
  - b. Head-to-Head. Winner of head-to-head match.
  - c. Sets. Loser of the fewest number of sets.
  - d. Games. Loser of the fewest number of games.
  - e. A method to be determined by the Championships Committee.
- II. The remaining semifinal play-off spot shall be determined from the second-place teams by the first of the following procedures that does so:
  - a. If each flight has the same number of teams, the team with the most team wins will advance. In the case of a tie, the procedures shall be the same as those in I. above.
  - b. If any of the flights have a different number of teams, the procedures shall be determined as follows:
    - 1. Games. The second-place team with the highest percentage of games won by them vs. games played by them in their round robin. Defaults **RECEIVED** shall not count. Retirements: only games played will be counted.
    - 2. A method to be determined by the championships committee: procedure to be announced prior to commencement of championships competition.
- III. The second-place team shall be placed into the semifinal play-off as follows:

#### W4.5-4.0-3.5

SF Match 1:	Winner of Gold Flight vs. Winner of Bronze Flight
SF Match 2:	Winner of Silver Flight vs. Best 2 <sup>nd</sup> Place Team with Best Overall Record

If a draw results in the 2<sup>nd</sup> Place Team playing against the 1<sup>st</sup> Place Team from its initial round robin flight, the draw shall be altered as follows: 2<sup>nd</sup> Place Team shall exchange places with first team listed from the other SF Match.

#### SF Winners advance to FINAL.
