### FORMAT:

2025 USTA 40 & over ADULT DALLAS CITY CHAMPIONSHIP and TEXAS SECTION M. and W., ALL NTRP LEVELS, will play **1 Singles and 3 Doubles**.

2025 USTA 40 & over ADULT NATIONALS M. and W., ALL NTRP LEVELS, will play **1 Singles and 4 Doubles**. M. and W. OPEN Level (5.0 and above) will play **3 Doubles**.

Texas Section fees will be collected at the player level. \$30.00/player. The individual player on a Sectionals advancing team will be responsible for registering themselves for the Sectional event in which they have qualified.

Teams advancing to the 2025 DALLAS TENNIS USTA 40 & over ADULT CITY CHAMPIONSHIP will be notified once their NTRP Level and Flight finishes regular league season play. (Dates will vary by League, NTRP Levels and Flights.) Captains will be asked to accept their invitation to the 2025 40 & over ADULT CITY CHAMPIONSHIP **within 24 hours** of receipt of DALLAS TENNIS' invitation.

DALLAS TENNIS and fellow captains are expecting to play all 4 lines throughout the 2025 CITY CHAMPIONSHIP.

### IMPORTANT!

Defaulting 2 lines during Post Season Play and Weekend Events.

Defaulting Lines during Post Season Play, including Local League Playoffs, City Championship and Weekend Events:

DALLAS TENNIS expects advancing teams to field all lines throughout the Post Season Play. Should a team accept their playoff spot and then default 2 lines over Post Season Play, **EVERY** player on the defaulting team will be allowed to play Dallas' local league but will be INELIGIBLE for ALL Post Season Play and Sectionals for a period of one (1) year from the date of penalty regardless of Age Division, ADULT or MIXED and NTRP Level.

For **2025 40 & over ADULT CITY CHAMPIONSHIP**, DALLAS TENNIS will utilize the following criteria to determine the Best OVERALL 3<sup>rd</sup> Place Team:

The BEST OVERALL 3<sup>rd</sup> Place Team(s) shall be determined from the third-place teams by the first of the following procedures that does so:

If each flight has the same number of teams, the team with the most team wins will advance. In the case of a tie, the procedures shall be:

- a. Individual Matches. Winner of the most individual matches in the entire competition.
- b. Head-to-Head. Winner of head-to-head match.
- c. Sets. Loser of the fewest number of sets.
- d. Games. Loser of the fewest number of games.
- e. A method to be determined by the championships committee: procedure to be announced prior to commencement of championships competition.

If any of the flights have a different number of teams, the procedures shall be determined as follows:

Games. The third-place team with the highest percentage of games won by them vs. games played by them in their round robin. Defaults RECEIVED shall not count. Retirements: only games played will be counted.
